Margots stands on a wooded hill above the Chickahominy River in the sparsely populated northeast section of Charles City County. The site commands an unspoiled view of the river and a marsh, called Eagle's Bottom. The house has sustained alterations, but most of its fine exterior brickwork and some interior trim remain intact. The three-bay brick structure was one or one and a half stories above basement until raised by addition of a frame second story in the nineteenth century. Exterior dimensions above water table are 44'4" by 20'8". The center stair passage is flanked by single rooms with an interior-end chimney at the north end and exterior chimney to the south. With the exception of a portion of the north gable which is laid in Flomish bond, all brickwork is English bond. A unique feature of the house is the glazing of all headers on the east and west facades, resulting in a horizontal striated pattern. The full effect of this treatment is now diminished by a peeling coat of white paint. Random glazing is found on the gable ends, and a line of glazed headers follows the rake line of the original roof. The T-shaped chimney shafts are topped with caps consisting of four corbels. The sides of the exterior chimney are shouldered at the first and second story levels. An unusual feature of the upper shouldering is the splay carried around three sides of the chimney at the same level. In most eighteenth century examples, any splay of the face is placed above that of the sides. A chimney treatment similar to Margots' is seen at the George Reid House, an early eighteenth century frame house in Williamsburg.

The beveled water table is laid in alternating headers and stretchers. A similar course of beveled bricks is employed as weathering under the window sills. All door and window arches have been replaced, and some of the brickwork of the southern end has been rebuilt. Exterior doors, frames, and sash are modern replacements. An end door to the north room is also modern, but it may be in the location of an original opening.

The closed-stringer stair with pulvinated frieze is similar to other late seventeenth or early eighteenth century examples at the Keeling House in Virginia Beach and the Mason House in Accomac. The stair ascends to the second floor in three runs separated by two landings. The hand rail is not supported by balusters as in the Keeling House and the Mason House, rather, a rectangular center rail running parallel to the hand rail and stringer connects the posts. The rail of the main run is new, but an original rail survives in the short run above. Boarding below the stringer is modern replacement. A small four-panel door below the stair gives access to steps to the basement, and a larger door of the same form serves the south room. The entrance from the first floor hall into the north room and the north room closet are hung with two-panel doors. These four original doors retain their early floriated HL hinges. All mantels are replacements.

The major late addition to the house is the frame second floor, an alteration that resulted in the loss of the original roof framing. Crude modern shelters have been built above the west door and both end doors, and a frame single room was added to the east. Original brickwork was not removed in construction of this room and the second floor.

STATEMENT OF SIGNIFICANCE

Margots typifies the solidarity of the few surviving circa 1700 medium-sized houses of Tidewater Virginia, and it exhibits several features not found on other houses of the period. Although the construction date and early history have not been documented, the house can be attributed to the late seventeenth or early eighteenth century on stylistic evidence.

The three-bay elevation with one exterior and one interior-end chimney is similar to other Virginia Houses of the seventeenth and early eighteenth centuries, but the exterior chimney does not have the extremely robust appearance of most seventeenth century examples. The straited pattern of the glazed-header English bond on the principal facades is without parallel in the Commonwealth. The interior is distinguished by a fine closed-string stair with interesting period details.

Although the building's appearance has been defaced by additions of inferior quality, the exterior brick fabric is largely intact, and the interior retains some of its original trim. The building is unoccupied but is in basically sound condition.

The early history of Margots is indefinite as a result of destruction of most of Charles City County's colonial records during the War Between the States. The known ownership is complicated, and the property has been known by a variety of names since the late eighteenth century.

The first reference to what appears to be the Margots land is a patent issued to John Dansey in 1636 for 350 acres "a mile up Chickahominy River on the N. W. side called by the name Claye banke, the point butting S. E. upon the said river right opposite against the sunken marshes . . "The patent is given as being in James City rather than Charles City County. This discrepancy may be an error in county name or the result of variations in the county boundary lines in the 1630's. A 1686 patent to Francis Dancy for 287 acres on the west side of the Chickahominy River may also refer to the Margots land.

The earliest owner who can be definitely established for Margots is Francis Hardyman Dancy, who owned 1325 acres there in 1782. A Francis Dancy is recorded as serving in the Charles City Committee of Safety in 1774, and he was probably a descendent of the seventeenth century Dancys previously mentioned. Deeds of 1794 from F. H. Dancy to Edward Dancy and from Edward Dancy to John Ballard describing 150 of the 507 acres surrounding the house refer to the property as "Margots." The deed makes reference to "all houses, gardens . . and appurtences." The remainder of the 507 acres was deeded to Ballard in separate lots, and there are no references to buildings on the lots.

In 1797, the 507 acres were sold to Turner Christian, clerk of the Charles City County Court, and it remained in the Christian family until 1836, by which time the property had increased to 704 acres. The entire tract was called "Clay Bank," although the Lamb family property to the south was also called by that name. The Eagle's Nest property is elsewhere referred to as "Upper Clay Bank." A boundary dispute in 1850 resulted in a survey of the property which is the basis for all surveys since. This survey, done by Lycurgus Lamb, is in the Charles City County Court House, Plat Book I, p. 101, 1850. Blake deeded Upper Clay Bank to David Hansford in 1854. Hansford immediately sold the property, then containing 730 acres, to Junius Lamb, who owned Clay Bank adjoining to the south. In 1864 Lamb deeded the 730 acres, then called "Gravel Hill", a name probably taken from a part of the property called "Gravelly Hill" in a 1794 deed. The property passed through various ownerships in the remainder I the nineteenth century, and by 1889 it had been enlarged by the addition of a 390 acre tract known as "Carey's." C. W. Beale purchased the land in 1933, and the house became known as "Eagle Lodge." In 1973 the property, including the early house, was sold to the Virginia Commission of Game and Inland Fisheries by the Beale Estate.
