DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

WELBOURNE (description)

The Welbourne residence is a rambling yet dignified country house, enlarged and embellished by successive generations of owners. Though many tastes and styles are represented, all harmonize to give a very lively and interesting total effect. This evolutionary quality is evident also in Welbourne's rich and varied furnishings - an extraordinary assemblage accumulated for the house by previous generations of the owner's families.

The earliest portion of the house was constructed around 1770, and it now forms the main part of the south wing. As originally built it was a two-and-one-half story single pile farmhouse constructed of the local stone laid in a random rubble. It had a three-bay front, dormer windows, and interior end chimneys. Though much altered on the interior, some original eighteenth-century woodwork survives in the dining room and on the second floor.

The present two-story front or main portion of Welbourne was added around 1820, when the property was purchased by John Peyton Dulaney. This stuccoed brick section was originally quite plain, being a simple rectangular block of five bays with gable roof and interior end chimneys. It was connected to the earlier section by a transverse hall containing the stair. Its interior woodwork with its planed door and window surrounds, ornamented with corner blocks, and deeply molded mantel shelves supported on free-standing columns is typical of the region and period. This main portion was enlarged in the 1830's by the addition of flanking one-story octagonal ended wings. The east wing serves as a music room and the west is a guest bedroom. Both wings can be directly entered from the outside through handsome three-part Greek Revival doorways located on the front or north walls. The two-story porticos with their slender Italianate-style square columns fronting the main section and the east wall of the south wing were added in the 1850's. Porticos of this type are rare in Virginia and give Welbourne a distinctive aspect. The house was further enlarged in the 1870's by the addition of a two-story section on the rear of the south wing. This section is surrounded by a modillion cornice and has a two-story frame bay window on its south wall. The many sections of the house are tied together visually by their uniform covering of buff colored stucco with painted joints.

Welbourne retains numerous early outbuildings including a school-house, spring house, tenant house, tool house, servants house, smokehouse, and a small cottage with stone chimneys traditionally called "The Old Dwelling", believed to be the oldest structure on the place. To the east of the house is an extensive old-fashioned garden containing box bordered walks, flower beds, and both ornamental and shade trees. At the end of the garden is one of Virginia's earliest swimming pools, constructed around 1916. The front of the house is approached through an informal park along an axial avenue. The whole complex is surrounded by the beautiful and largely unspoiled countryside for which Northern Virginia is so famous.

STATEMENT OF SIGNIFICANCE

HISTORY

Set in a classic Northern Virginia rural setting, Welbourne survives as a significant example of a late-eighteenth century stone farm house that has evolved into an imposing mansion. Reaching its heyday in the years before the outbreak of the War between the States, the main house is evocative of the mid-nineteenth century plantation life in Virginia. Besides the main house numerous outbuildings and farm structures remain to further attest to the extensive farming operation conducted here. Associated with a prominent Northern Virginia family for over 150 years, Welbourne has grown with each generation leaving its own architectural embellishment.

John Peyton Dulany purchased the stone nucleus of the present house circa 1819 and shortly thereafter made the major additions to the house in the form of the front section. The son of Benjamin Tasker Dulany of Alexandria and the grandson of Daniel Dulany, the Younger, of Maryland, he came from a distinguished lineage.

At his death Welbourne descended to his son, Richard Henry Dulany (1820-1906). Dulany was a noted planter and sportsman in the area and in 1853 founded the Upperville Colt and Horse Show, the oldest horse show in the United States. During the War between the States Dulany rose from captain to colonel of the famous Laurel Brigade, Seventh Virginia Cavalry. At his death in 1906, Welbourne passed to his daughter, Fanny Dulany (died 1928), the wife of J. Southgate Lenmon of Baltimore, Maryland. Later the property was inherited by their daughter, Fanny Carter Lenmon (1875-1956), the wife of Nathaniel Holmes Morison and mother of the present owner.

Reminiscent of an earlier way of life, Welbourne in its park-like setting, surrounded by fields and pastures, offers a continuity with the past. Under the care and supervision of five generations of the same family, the house also retains a rich collection of furnishings including many family portraits.
