DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The original portion of Winona is a small story-and-a-half brick structure with a gable roof and simple box cornice. The outside of the house, exclusive of the chimney base, measures 32'6" long by 27'6" wide. Its brickwork is laid in Flemish bond with random glazed headers, and has a beveled water table. The building's west wall fell many years ago and was replaced with clapboarding. A section of the north wall also fell and has been replaced by brick laid in five course American bond. Winona's outstanding architectural feature is its fine exterior chimney on the eastside with its three freestanding stacks set diagonally on the base. The caps of the stacks are engaged and are decorated with mouse-tooth bricks. This same type of decoration appears around the base just below the wash. Unfortunately the bottom portion of the chimney has been hidden by a later one-story frame addition. A second one-story frame wing has recently been added to the west side of the house. Originally the house probably had dormers; however, the present ones appear to be a renewal.

The first floor of Winona is divided into two rooms and a side hall containing the staircase. Unfortunately the house retains little if any of its interior woodwork. The present woodwork is very plain and probably dates from the late-nineteenth century.

Winona has recently been renovated.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

The date of this Eastern Shore farmhouse is uncertain, however, it is thought to have been built by Mathew Patrick after 1681 when he acquired a reversionary interest in the property on which the house is located. It is reported that a brick in the chimney is dated "1645", and that a brick in the west wall is inscribed "1649".

Despite the uncertainty of its date Winona is of great architectural significance as it is the only known seventeenth century house in the country, other than Bacon's Castle, to have diagonally placed triple chimney stacks. Such chimney treatment is indicative of the architectural consciousness of seventeenth century Virginia. It also demonstrates the delayed impact that English architectural forms had in the colonies. The importance of the chimney at Winona, as an excellent example of late medieval architecture, cannot be exaggerated.

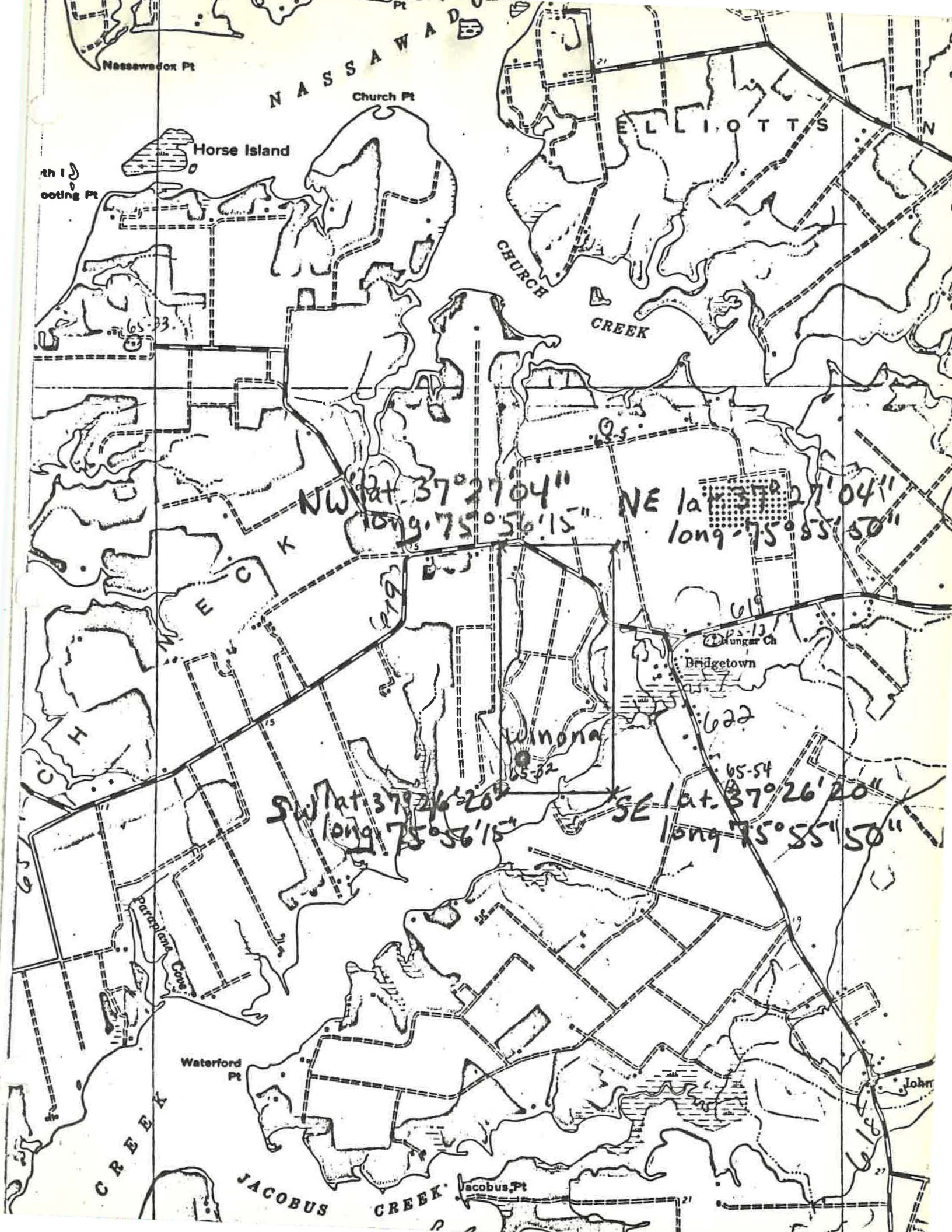
