ESCRIBE THE PRESENT AND ORIGINAL (II known) PHYSICAL APPEARANCE

a. BACKGROUND INFORMATION: The colonial capital of Virginia, with a span of importance almost exactly coinciding with the eighteenth century colonial period, never approached Charleston as a metropolis, though it was the political and cultural center of one of the leading colonies. Its particular value, aside from its political importance, stems from the remarkable interpretive program which for some years has been carried on by Colonial Williamsburg. For a century and a half a quiet college town and county seat, Williamsburg today is an outstanding example of restoration and interpretation. The aim of the restoration has been to "re-create accurately the environment of the men and women of 18th-century Williamsburg and to bring about such an understanding of their lives and times that present and future generations may more vividly appreciate the contribution of these early Americans to the ideals and culture of our country."

The restoration, begun in 1927 under the auspices of Mr. John D. Rockefeller, Jr., to date has involved the razing or removal of some 600 buildings, the restoration of approximately 100, and the reconstruction of about 350 on their original sites. Noteworthy restorations include the Wren Building (1695-1702), Brafferton Hall (1723) and the President's House (1732), all of the College of William and Mary; the Public Magazine (1714); the Ludwell-Paradise House (1717); the Old Court House (1770); Bruton Parish Church (1710-15); and the George Wythe House (1755). Among the more ambitious reconstructions are the Governor's Palace (original built 1706-20); the Colonial Capitol Building (original constructed 1701-05); and the Raleigh Tavern (original built before 1742). Mention also should be made of a newly completed Reception Center, located outside the restored area, which is the center of the interpretive program for Colonial Williamsburg.

b. BOUNDARIES: Following boundaries have been established for "Historic Colonial Area" per Section 26-45, Article XI, Williamsburg City Code, July 1, 1966:

"Beginning at a point on the north side of Duke of Gloucester Street two hundred feet east of the east line of North Henry Street said point also being ten feet west of the John Blair House; thence northerly to the south side of Prince George Street; thence easterly to a point approximately sixty feet west of west line of Nassau Street; thence in a northerly direction across Prince George Street; thence continuing along the west side of the Goodwin property approximately one hundred and sixty feet; thence easterly to the east side of Nassau Street; thence in a northerly direction along the east side of Nassau Street to the north side of Scotland Street; thence easterly one hundred and twenty feet to the west property line of the Governor's Palace site; thence in a northerly direction to south side of Lafayette Street; thence easterly along south side of Lafayette Street to the west property line of the Colonial Williamsburg warehouse area; thence in a southeasterly direction to the south line of Franklin Street; EE INSTRUCTIO
