DHR Deputy Director Stephanie Williams opened the meeting by welcoming Board members and attendees and explaining her role as host of the live joint meeting. She explained how the meeting would proceed through the joint session as well as how to participate in the separate sessions of the SRB and BHR. She introduced Catherine Shankles of the Office of the Attorney General, Julie Langan, Director of DHR, IT staff Andy Poole and Joe Dimicelli, and DHR staff.

State Review Board (SRB)

Chair Jody Lahendro called the meeting to order at 10:12 a.m. He began by reading the emergency declaration that the SRB is meeting online to perform necessary business of the Board and he made a motion for approval of the meeting format and agenda. Mr. Salmon seconded the motion. Deputy Director Williams proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Lounsbury, Mr. Salmon, and Dr. Allen voted in the affirmative.

Chair Lahendro asked for a motion to approve the December 12, 2019, meeting minutes. Dr. Allen made the motion and Dr. Lounsbury seconded. Deputy Director Williams proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Lounsbury, Mr. Salmon, and Dr. Allen voted in the affirmative.

Chair Lahendro invited the SRB members to introduce themselves. He explained the role of the SRB and the process of Register designation.

Board of Historic Resources (BHR)

BHR Chair Fairfax introduced herself and invited BHR members to introduce themselves. Chair Fairfax read the emergency declaration that the BHR is meeting online to perform necessary business of the Board. She requested a motion for approval of the meeting format and agenda. Vice-Chair Atkins-Spivey moved and Ms. Luck-Brimmer seconded. Deputy Director Williams proceeded with a roll call vote. Chair Fairfax, Vice-Chair Atkins-Spivey, Mr. Ruth, Ms. Luck-Brimmer, Mr. Harris, and Ms. Kim voted in the affirmative.

Chair Fairfax asked for a motion to approve the December 12, 2019, meeting minutes. Ms. Kim made the motion and Vice-Chair Atkins-Spivey seconded. Deputy Director Williams proceeded with a roll call vote. Chair Fairfax, Vice-Chair Atkins-Spivey, Mr. Ruth, Ms. Luck-Brimmer, Mr. Harris, and Ms. Kim voted in the affirmative.

Chair Fairfax explained the role of the BHR and introduced Director Langan.

Director's Report:

Director Langan thanked DHR staff and board members who worked together to prepare for today's meeting. She said that she currently is spending considerable time explaining to various parties that Confederate monuments are not protected from removal simply due to their inclusion in the VLR and/or NRHP. She said a new state law goes into effect July 1, 2020, that delegates authority to local governments for monuments within their jurisdiction. She added that the BHR will promulgate regulations for contextualizing monuments and those regulations will be posted on the BHR webpage by the end of July 2020. Director Langan next discussed upcoming highway markers. During Black History Month, Governor Northam sponsored a marker contest, with 5 of the 10 winners on today's BHR agenda and the other 5 to be considered at the BHR's next scheduled meeting in September 2020. DHR also has been receiving inquiries about the removal of some markers based on topic; this matter will be addressed during today's BHR afternoon session. Director Langan described Virginia's created Commission for Historical Statues in the United States Capitol, created during the General Assembly's last session. The Commission will make recommendations on whether the Lee statue should continue to represent Virginia in the US Capitol, and if not, who should replace him. The eight-member panel has until December 1, 2020, to issue its report. The Commission is in the process of being appointed, and DHR will provide staff support. The General Assembly will convene for a special session in August 2020. Originally the special session was planned to discuss budget impacts caused by the COVID-19 pandemic, but is not likely to include additional topics. Director Langan concluded with

vacancies that currently exist on the BHR and SRB, with expectations that those will be filled before the next Board meeting in September 2020.

Deputy Director Williams proceeded with a roll call vote. Chair Fairfax, Vice-Chair Atkins-Spivey, Mr. Ruth, Ms. Luck-Brimmer, Mr. Harris, and Ms. Kim voted in the affirmative.

American Evolution Signs Attached to Markers

Dr. Loux presented the request by the Virginia Tourism Corporation to retain these signs indefinitely as attached to the existing highway marker posts.

Chair Fairfax asked for a motion to approve the request. Ms. Luck-Brimmer made the motion and Ms. Kim seconded. Deputy Director Williams proceeded with a roll call vote. Chair Fairfax, Vice-Chair Atkins-Spivey, Mr. Ruth, Ms. Luck-Brimmer, Mr. Harris, and Ms. Kim voted in the affirmative.

Highway Marker Program Policy Discussion

Dr. Loux requested that the Board reaffirm the purpose of the marker program.

Ms. Kim stated her support for the Board to formally adopt the language as stated in the previous stand-alone statement of purpose. Mr. Harris agreed that this action stood as a timely reminder to the general public and noted the significance of the statement's date of origin as 2018, as it would not be viewed as a reaction to current events. Dr. Loux pointed out that the press releases for new highway markers makes the educational nature of the markers quite clear. Dr. Fairfax recommended that this articulation be placed on the DHR website, given current events.

Ms. Kim made a motion to affirm the statement of purpose of the highway marker program. Mr. Harris seconded the motion. Deputy Director Williams proceeded with a roll call vote. Chair Fairfax, Vice-Chair Atkins-Spivey, Mr. Ruth, Ms. Luck-Brimmer, Mr. Harris, and Ms. Kim voted in the affirmative.

Dr. Loux then explained the existing DHR policy for the retirement of highway markers, dating to 2015.

Mr. Ruth stated his agreement with the policy and inquired if the sponsor will be notified of the errors, so that the sponsor might have the opportunity to correct the error(s). Chair Fairfax agreed that this was important. Dr. Loux noted that the absence of state funding for replacement markers, so sponsor fundraising was essential to a replacement, but was not always possible. Chair Fairfax requested the insertion of language to notify the sponsor of the marker. Ms. Shankles requested that the Board clarify both aspects in a motion: to approve the motion and

also amend for the additional language. Ms. Luck-Brimmer and Mr. Ruth supported this approach. Dr. Loux agreed to coordinate the exact language with Chair Fairfax for inclusion in the official policy.

Chair Fairfax made a motion to accept the retirement policy in addition to adding notification to the original sponsor. Ms. Luck-Brimmer seconded the motion. Deputy Director Williams proceeded with a roll call vote. Chair Fairfax, Vice-Chair Atkins-Spivey, Mr. Ruth, Ms. Luck-Brimmer, Mr. Harris, and Ms. Kim voted in the affirmative.

3. **Bois Dore, Fairfax County, DHR No. 029-6641, Criterion C
Architectural historian Thomas Waterman's papers were noted as being at several repositories including the Colonial Williamsburg Foundation and the Library of Congress.

Chair Lahendro asked for a motion to approve the PIF. Dr. Lounsbury made the motion and Mr. Salmon seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

4. Bowman, Daniel, House, Shenandoah County, DHR No. 085-0282, Criterion C Historic-period alterations to the dwelling's floor plan and number of stories were discussed. The house does not show the same Germanic cultural influences as other documented houses in the Shenandoah Valley. Further research will be needed to ascertain the dwelling's construction date.

Chair Lahendro asked for a motion to approve the PIF. Dr. Lounsbury made the motion and Dr. Allen seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

5. Browntown Historic District, Warren County, DHR No. 093-5032, Criteria A and C The SRB endorsed the PIF without additional comment.

Chair Lahendro asked for a motion to approve the PIF. Vice-Chair Bon-Harper made the motion and Dr. Lounsbury seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

6. Burner, Jonas, Farm, Shenandoah County, DHR No. 085-0292, Criteria A and C The property's historic agricultural use was discussed, as well as its general archaeological potential due to its riverside location on a landform with high potential for prehistoric occupation.

Chair Lahendro asked for a motion to approve the PIF. Vice-Chair Bon-Harper made the motion and Dr. Allen seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

7. **Hough, Bernard, House, Loudoun County, DHR No. 053-0676, Criterion C Additional information about the historic owner's association with a local dispute over slavery was noted. The dwelling's brick construction also was noted as the area is known more for stone construction.

Chair Lahendro asked for a motion to approve the PIF. Vice-Chair Bon-Harper made the motion and Dr. Lounsbury seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

8. Δ **Mount Pleasant Baptist Church and Cemetery, Prince William County, DHR No. 076-6009, Criterion A and Criteria Considerations A and D

The building's architectural evolution as it reflected changes in the local community was discussed.

Chair Lahendro asked for a motion to approve the PIF. Mr. Salmon made the motion and Dr. Allen seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

9. **Western Loudoun County Roads, Loudoun County, DHR No. 053-6473, Criteria A and C The project is planned to include an MPD and at least one nomination.

Chair Lahendro asked for a motion to approve the PIF. Vice-Chair Bon-Harper made the motion and Dr. Lounsbury seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

Eastern Region......presented by Marc Wagner and Elizabeth Lipford

1. Δ**Brookbury Farm, City of Richmond, DHR No. 127-0301, Criteria A and C and Criteria Consideration G

The SRB endorsed the PIF without additional comment.

Chair Lahendro asked for a motion to approve the PIF. Vice-Chair Bon-Harper made the motion and Dr. Allen seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

2. **College Terrace Historic District, City of Williamsburg, DHR No. 137-5021, Criteria A and C The neighborhood's history of segregation was discussed. Census data indicates the neighborhood was occupied by white residents. The district's historic boundary was discussed. It was drawn to follow the neighborhood's original plat and includes the area designed by the College of William & Mary's architect. The neighborhood already is a local historic district.

Chair Lahendro asked for a motion to approve the PIF. Vice-Chair Bon-Harper made the motion and Dr. Lounsbury seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

3. **Cruser Place Historic District, City of Norfolk, DHR No. 122-5985, Criteria A and C The area's history of racial segregation was discussed. The historic boundary was discussed as it pertains to a neighboring listed historic district.

Chair Lahendro asked for a motion to approve the PIF. Dr. Lounsbury made the motion and Mr. Salmon seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

4. Fairfield-Sandston Historic District, Henrico County, DHR No. 043-6271, Criteria A, B, and C Mr. David Sacks of Henrico County spoke in support of the PIF and said that funding has been secured for the project's architectural survey and preparation of a nomination. The neighborhood's history of segregation was discussed. The World War I munitions plant in the area was discussed, however, none of the architectural resources associated with it are still extant.

Chair Lahendro asked for a motion to approve the PIF. Dr. Lounsbury made the motion and Vice-Chair Bon-Harper seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

5. **Jefferson Manor Motel Apartments, City of Virginia Beach, DHR No. 134-5383, Criteria A and C The SRB endorsed the PIF without additional comment.

Chair Lahendro asked for a motion to approve the PIF. Dr. Lounsbury made the motion and Vice-Chair Bon-Harper seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

6. **Resort Hotels/ Motels in Virginia Beach Built in the 1950s and 1960s Multiple Property Documentation Form, City of Virginia Beach, DHR No. 134-5721

The history of segregation at public beaches in Virginia Beach was discussed. The principal public beaches were accessible only to whites, but at least two other areas were used by African Americans. The architectural diversity of resources identified during the PIF process was noted.

Chair Lahendro asked for a motion to approve the PIF. Vice-Chair Bon-Harper made the motion and Dr. Allen seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

7. **Richmond Foundry and Manufacturing Complex, City of Richmond, DHR No. 127-6847, Criteria A and C

Manufacturing operations within the complex were discussed.

Chair Lahendro asked for a motion to approve the PIF. Dr. Lounsbury made the motion and Mr. Salmon seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

8. Δ **Tenth and Page Historic District, City of Charlottesville, DHR No. 104-5088, Criteria A and C Chair Lahendro recused himself from discussion of this PIF due to his association with the City of Charlottesville's Board of Architectural Review. The area's antebellum history was discussed.

Vice-Chair Bon-Harper asked for a motion to approve the PIF. Mr. Salmon made the motion and Dr. Lahendro seconded the motion. Jim Hare proceeded with a roll call vote. Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative and Chair Lahendro abstained.

9. Westham, Henrico County, DHR No. 043-0222, Criteria A and C The SRB endorsed the PIF without additional comment.

Chair Lahendro asked for a motion to approve the PIF. Vice-Chair Bon-Harper made the motion and Dr. Allen seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

10. WSVS Radio Station and Transmitter, Nottoway County, DHR No. 067-5068, Criteria A and B Potentially comparable examples of radio transmission towers from the 1940s were discussed, as well as the career of broadcaster Jody Rainwater.

Chair Lahendro asked for a motion to approve the PIF. Dr. Lounsbury made the motion and Dr. Allen seconded the motion. Jim Hare proceeded with a roll call vote. Chair Lahendro, Vice-Chair Bon-Harper, Dr. Allen, Dr. Lounsbury, and Mr. Salmon voted in the affirmative.

Chair Lahendro asked for a motion to adjourn the SRB meeting. Dr. Allen made the motion and Dr. Lounsbury seconded. The SRB members voted unanimously in the affirmative.

The SRB meeting was adjourned at 5:44 p.m.
