Good afternoon,

I'm not sure if the deadline for suggestions has passed, but I would like to nominate Maggie L. Walker to replace the current state statue of Robert E. Lee in the U.S. Capitol building.

I have a unique perspective in that I have worked in the Capitol building for almost 2.5 years. The primary purpose of my job is to interpret the building (its art, architecture, and history) as well as the history and function of Congress. I have watched thousands of people visit the Capitol and come face to face with the National Statuary Hall collection, often for the first time.

The purpose of this collection, as I'm sure you know, is to offer a state identity through art; as an answer to the questions "Who are the citizens of this state?" and "What do they respect and stand for?" It has been difficult to be a citizen of Virginia myself and have to ask my fellow Virginians to come face to face with Lee, a historical figure who no longer represents many Virginia values. While he is a figure who made an historical contribution, each state only gets two statues to represent themselves. With George Washington remaining, why not also show a more modern figure that Virginians can connect to?

I have read through many of the email submissions published on your website, and I noticed that Ms. Walker has been recommended by others. I won't belabor the point, but her role as the first black woman to charter a bank and serve as its president, her contributions to bettering the lives of African Americans, and her support for people with disabilities make her a commendable recommendation.

At present, there are no state statues that represent black women in the collection. I'm sure you can imagine what it's like to watch visitors, especially young students, look at this statue and see that this example is what our state legislature has left in the halls of Congress as a representation of who we are.

Thank you for undertaking this initiative and considering my recommendation. It is time for Virginia to represent itself accurately in the building that is meant to represent all Americans.

Commission for Historical Statues in the United States Capitol was in a Manassas paper this past week, yet the commission has been in existence since at least 1 July 2020, and the decision made to remove the statue of Robert E.
