
Project Background

 April 2017: Initial proposal for Downtown Mall historic context study and management plan drafted by City staff.

 April 2021: Cost Share Survey and Planning Grant application for Downtown Mall historic resources survey (Phase 1) submitted to DHR by City staff.

 June-September 2021: DHR awards City cost share grant City, produced project scope based on grant application, and hired Robinson & Associates, Inc. to perform scoped work.

Project Background



 Survey of resources comprising the designed landscape of the Downtown Mall.

 Survey report providing historic context covering design and develop of the Downtown Mall.

 Preliminary Information Form establishing potential National Register of Historic Places eligibility the Downtown Mall.





A historic resources survey is a **process** of identifying and gathering data on a community's historic resources.



The survey will record including Downtown Mall resources including City-owned public art installations, bollards, planters, benches, light posts, tree wells, drainage systems, and signage.



 This project will not include resurvey of buildings bordering the Downtown Mall.

 The survey will be conducted from the public right-ofway.

o Data gathered during survey will be available to public.

 This project will **not** result in a National Register listing for the Downtown Mall.

January 2022: Architectural Survey


March 2022: Draft survey materials and report submitted to DHR and City


